

62 Sales - Trailer Rental Agreement

Renter must be 25 years of age or older to rent. Credit/Debit card used for payment or deposit MUST be in renter's name. Renter MUST have a valid drivers license. Renter MUST have in-force, full coverage auto insurance in their name. Renter accepts FULL responsibility for any damage to the unit and agrees to ALL terms and conditions listed below. Prior to pick-up, renter must provide via email, or in person a copy of the renter's valid driver's license and tow vehicle insurance certificate. Please note that any damage to the rental unit will be tied to the tow vehicle insurance policy.

Reservations - Your reservation is NOT CONFIRMED until your requested rental deposit is paid.

You will receive a separate email within 24 hours after your reservation requesting your deposit and confirming rental details. You may also call a rental agent to pay by phone at 812-720-3810. In the event your deposit is not received within 24 hours of booking, your reservation will be cancelled.

Pick-Up & Drop-Off Times - Rental campers may ONLY be picked up between the hours of 3-6pm on the first day of rental period. Rentals may NOT be picked-up on Sundays. Rental Campers MUST be returned by 11am on the final day of rental period, or an additional rental night will be deducted from your deposit. Rentals returning on SUNDAYS ONLY must be dropped by 5:00pm.

Rescheduling - If you must cancel your reservation within 30 days of your rental start date, you may reschedule your reservation for a \$50 fee. You must email 62 Sales at mason@62sales.com and notify us of your desire to reschedule and pay the \$50 fee within 30 days of your rental start date. All rescheduling is based upon availability. The deposit that you placed towards your initial reservation will be rolled forward to your new reservation. You have one year from the date of the \$50 rescheduling fee to reserve and utilize your trailer from 62 Sales or you will forfeit your deposited amount. Reservations cancelled within 48 hours of pick-up will lose initial rental deposit collected.

Security Deposit - A \$500 security deposit (the "Security Deposit") is required for each camping trailer rental and due on or before pick-up. The security deposit covers the cost in the event there are missing or damaged items inside, or damages to the outside of the camping trailer during your rental period. In addition, a **\$200 BLACK & GRAY TANK DUMP FEE may be charged for rentals returned prior to sanitary dumping.** A 62 Sales associate may request a paid receipt of dump. If necessary, additional costs associated with missing or damaged items inside or outside the trailer may be charged to your credit card or debit card on file. The security deposit may also be used to pay any monies owed to 62 Sales after the unit is returned in good condition under this agreement. Any damage incurred over the initial \$500 security will directed towards tow vehicle insurance policy. **PLEASE NOTE:** Our merchant processor (Square) states that it may take 7-10 business days once the unit is checked in and confirmed.

Definitions - “Agreement” means all terms and conditions found in this form, any addendum, and any additional materials we provide at the time of reservation/rental. “You” or “your” means the person identified as the renter on this form, any persons signing this agreement, and any person or organization to whom charges are billed by us at its or the renters direction. All person’s referred to as “you” or “your” are jointly and severally bound by this agreement. “We”, “our” or “us” means 62 Sales, LLC. “Trailer” means the non-motorized trailer identified in this agreement. “Loss of use” means the loss of our right or ability the use the trailer for any reason because of damage to it, or loss of it during this rental. Loss of use is calculated by multiplying the number of days from the date of damage to the trailer until it is repaired or replaced times the daily rental rate.

Rental Indemnity, and Warranties - This is a contract for the temporary use of the trailer within the geographic region listed above. This contract does not provide any other party the right tow or otherwise move the trailer. Unauthorized use of the trailer outside of the geographic region, and uses noted above will result in, at MINIMUM, a loss of the security deposit, and potentially, legal action. We may repossess the trailer at your expense without notice to you if the trailer is abandoned or used in violation of any applicable laws or this agreement. *You agree to indemnify us, defend us and hold us harmless from all claims, liability, costs and attorney fees we incur resulting from, or arising out of, this rental and your use of the Trailer. We make no warranties, express, implied, or apparent, regarding the Trailer, no warranty of merchantability and no warranty that the Trailer is fit for a particular purpose.*

Toll Fees (If Applicable) – All rental units are tracked by onboard GPS tracking devices. Any rental unit pulled across a toll bridge will be billed accordingly. Toll fees will be deducted from your rental deposit.

Campground Reservations (If Applicable) – We are not responsible for campground reservations. All campground reservations must be made separately with the campground’s reservation agency. All campground and campsite fees are separate from and in addition to the rental prices and fees under this agreement. No refunds will be given for campsite reservation errors.
